

ACCESS INVESTIGATION FORM

SECTION I

In compliance with San Diego International Airport Rules and Regulations, an access investigation involving a criminal history records check and possible employment history verification, must be completed before an applicant is granted an airport identification badge (SAN ID Badge) allowing unescorted access to the airport's restricted Security Identification Display Area (SIDA).

In SECTION II, list your EMPLOYMENT/ UNEMPLOYMENT/ EDUCATION/ MILITARY/ VOLUNTEER SERVICE history in chronological order, beginning with the most recent period. Provide information to complete a <u>FULL 10-YEAR</u> history. Clearly <u>PRINT</u> all information. If additional space is needed, copy the SECTION II page as many times as necessary. Please use this form only. DO NOT double side application. Be certain you verify and provide accurate phone numbers where references can be contacted. Advise references they may be contacted.

Provide a chronological 10 year history with <u>no periods of unaccountability</u>. Indicate exact <u>month and year</u> of each period of EMPLOYMENT, UNEMPLOYMENT, EDUCATION, MILITARY and/or VOLUNTEER SERVICE history.

 - (IV) Theft;
 - (V) Dishonesty, fraud, or misrepresentation;
 - (VI) Possession or distribution of stolen property;
 - (VII) Aggravated assault;
 - (VIII) Bribery; and

(IX) Illegal possession of a controlled substance punishable by a maximum term of imprisonment of more than 1 year, or any other crime classified as a felony that the Administrator determines indicates a propensity for placing contraband aboard an aircraft in return for money; or;

(xvi) Conspiracy (or attempt) to commit any of the acts referred to in clauses (i) through (xiv).
