

LIST OF ACCEPTABLE DOCUMENTS

ALL documents must be original and unexpired

***NEW APPLICANTS are required to present two (2) forms of identification. Any one of the following combinations:**

1. List A and B | 2. List A and C | 3. List B and C

***SAN ID badge renewals require:**

1. List A or 2. List B & C

***All AOA drivers must present a California Driver's License (new applicants or badge renewals).**

NOTE: If you are born outside the USA or not a US Citizen, you must provide one of the following numbers: 1) Alien Registration #; 2) I-94 Form #; 3) Non Immigrant Visa# 4) US Passport #; 5) Certification of Naturalization; or 6) Certification of Birth Abroad (DS-1350, FS-545 or FS-240)
