





Missed Approaches: A procedure to maintain safety, initiated by the pilot or Air Traffic Control (ATC) for a pilot to abandon the approach to landing.


# Total Arrivals Compared to (%) of Missed Approaches


# EARLY TURN STATISTICS

## Total Departures Compared to (%) of Early Turns




