NEW BUSINESS:

1. APPROVAL OF MINUTES:

RECOMMENDATION: Approve the minutes of the April 18, 2024, regular meeting.

ACTION: Moved by Board Member Martinez and seconded by Board Member Perez to approve staff's recommendation. Motion carried unanimously.

2. ELECTRICAL VEHICLE FIRE BRIEFING WITH CHIEF ROBERT REZENDE:

Battalion Chief, San Diego Fire-Rescue, Robert Rezende, MS, provided a briefing on Electrical Vehicle Fires that included, Battery Electric Vehicle Emergencies; Battery Types; EV Battery Pack Construction; Li-Ion Battery Mechanisms of Failure; Characteristics of DRAFT - Capital Improvement Oversight Committee Meeting Minutes Thursday, July 18, 2024 Page 2 of 4

LIB Fires; Why Are Battery Fires on the Rise; Exponential Increase: Production, Battery Electric Vehicles; How Quickly to They Ignite; Thermal Runaway- Fire/Explosion; Battery Pack Location; What is Stranded Energy; Parking Garage or Refueling Station; BEV Fire-Inside Hazards; Other Battery Electric Vehicles; and Lightning E-Motors E-Bus Fire.

Board Member Perez inquired if any of SAN's airport fleet are conversion vehicles. Rick Francis, Chief Operating Officer, Airside & Terminal Operations stated that this is being researched presently, and they will have answers soon. Chief Rezende commented that conversion vehicles/companies are not wrong, rather there is more research needed as there are currently no regulations.

Board Chair Cabrera commented that it is concerning, and it should be considered whether or not conversion vehicles should be allowed at the airport until there is more of an understanding of the industry. He also inquired about standard inspections to airport vehicles and shuttles when they are in an accident to ensure the battery is not damaged. Marc Nichols, Director, Ground Transportation, confirmed that they have requested Standard Operating Procedures and Inspection Criteria for all shuttle providers for the Authority.

Chair von Wilpert inquired about the electric vehicles that will be placed next to the jetliners on the airside and asked for confirmation that the airlines are responsible for those. Kim Becker, President/CEO, stated that the appropriate authority staff are researching this to determine the best measures that can be taken to address this concern.

3. NEW TERMINAL 1 AND FINANCIAL UPDATE:

Bob Bolton, Director, Airport Design & Construction; Brian DeLaura, Airline Technical Representative, Subject Matter Expert III, Airport Design & Construction and Maya Dayan, Director, Capital Financial Planning & Airline Relations provided a presentation on the New Terminal 1 (NT1) and Financial Update that included, New T1 Project Timeline and Milestones; Terminal and Roadways Construction Update; NT1 Airside Improvements; Logistics; ; and New T1 Costs through May 31, 2024; Contingency Summary; and Cash Flow and Sources of Funds.

4. NEW TERMINAL 1 CONCESSIONS UPDATE:

Deanna Zachrisson, Director, Revenue Generation & Partnership Development, provided a presentation on New Terminal 1 Concessions Update that included, Phase 1a- Restaurant and Retail Progress; 'Sense' of Place' Districts: Currently in 'Urban District;' Project Milestones; and Phase 1a- Opening September 2025.












