5. **PROGRESS UPDATE ON THE PREPARATION OF THE SAN DIEGO INTERNATIONAL AIRPORT - AIRPORT LAND USE COMPATIBILITY PLAN:**  
Keith Wilschetz, Director, Airport Planning, provided a presentation on the preparation of SDIA Airport Land Use Compatibility Plan, which included a status update; overflight; overflight factor purpose; Caltrans Handbook Guidance; ATAG overflight map; ATAG discussions on overflight policies; current technical analysis; steering committee poll results; and potential overflight policy.

Board Member Hubbs requested to see the existing regulatory notifications to compare to the recommended notifications.

Mr. Wilschetz stated that the current ALUCP does not have an overflight area. He stated that the plan requires that anyone in the current airport influence area be notified, but no specific boundaries were defined.

Board Member Panknin suggested that the REEBO Final Approach Fix be included because the Air Traffic Control might keep flights above 5,000' due to noise abatement.


