## APPENDIX G. 2026 NON-RESIDENTIAL LAND USES

The following is a list of the non-residential land uses that are located within the 2026 future base case 65 CNEL or greater contour at San Diego International Airport (SDIA). These properties are representative of the locations that were identified at the time this 14 CFR Part 150 Study was written. The structures currently meet the criteria of being noise-sensitive, non-residential land uses. Before being sound attenuated through the Quieter Home Program, all locations will have to be evaluated for location and structural eligibility in addition to other terms and conditions of the Quieter Home Program.
