Concessions and passenger services contribute to the Airport's overall agency Airport Concessions Disadvantaged Business Enterprise (ACDBE) Non-Car Rental Concessions goal of 23% in Federal Fiscal Years 2024-2026 and has historically achieved over 20% ACDBE participation. The overall ACDBE Car Rental Goal for goods and services vendors for the Car Rental Operators of the San Diego International Airport is 1.73%. ACDBE participation on these contracts will be applied towards the overall goal. The Airport encourages the participation of certified ACDBEs in concession contract agreements to be awarded.

The San Diego International Airport is a certifying agency of the California Unified Certification Program for the Airport Concession Disadvantaged Business Enterprise (ACDBE) and Disadvantaged Business Enterprise (DBE) certification.
